June 19, 1942 - June 17, 2025

Robert J. Adams Jr., age 82, passed away on Tuesday, June 17, 2025, in Chicago, where he was a lifelong resident. He was born on June 19, 1942, to Robert Adams Sr. and Lucille Adams. Lucille passed away just two days after his birth, and Robert was lovingly raised by Holly Adams, who became the mother he would know and cherish throughout his life.

Robert was a proud graduate of St. Mary of the Lake Catholic School in Chicago, where he met many of his lifelong friends. He later attended Senn High School, also in Chicago. He went on to serve his country honorably in the United States Air Force. After his military service, he earned his undergraduate degree from Northwestern University and later obtained his Juris Doctor from Kent Law School.

In 1976, through his dedication and tireless work ethic, he founded his law firm, Robert J. Adams & Associates, beginning a remarkable 49-year career as a bankruptcy attorney. Known affectionately as the "Bill Slayer" by clients and colleagues, Robert was one of the founding members of the National Association of Consumer Bankruptcy Attorneys (NACBA) and a proud recipient of its Lifetime Achievement Award.

Throughout his nearly five decades in practice, Robert helped thousands of individuals and families navigate financial hardship with compassion and

integrity. His advocacy changed lives, and his mentorship shaped a generation of young attorneys.

He loved practicing law, reading, watching movies, and—most of all—spending time with his family. He was a devoted father, proud grandfather, and loving husband who cherished every moment spent with his children and grandchildren. Robert was known for his sharp wit, generous heart, and unwavering sense of justice. He will be dearly missed by all who knew him, especially his lifelong childhood friends, with whom he met every Wednesday for their cherished “Romeo Lunch.”

Robert is survived by his beloved wife, Liqun “Linda” Xiong, who was his devoted partner and a true angel during his illness, providing constant care and unwavering love. He is also survived by his five children, Christine “Tina” Adams, Elizabeth (Robert Thorpe) Adams, Katharine (Louie Farkas) Adams, Robert “Bobby” Adams III, and Joseph “Joey” Adams; grandchildren, Richard (“Rickie”) S. Diaz, Joseph (“Joey”) Sutherland, Katharine “Katie” Adams, and Isabelle Adams; great-grandson, Anthony Sutherland; stepchildren, Tammy and James Du; sister-in-law, Linin “Grace” Xiong; cousins, Louis Friend and Robert Benjamin; and former wife, Marta Jensen.

He was preceded in death by his wives, Martha and Gerrie Adams, and by his grandson, Robert J. “Robbie” Diaz.

“ Tribute to Robert J. Adams

My dad's life was shaped by challenges, not the least of which was me. Born while he served in the Air Force, I was just a baby when tragedy struck. At 21, we were involved in a car accident that claimed my mom's life, leaving him to raise me alone. He showed resilience, even at such a young age, and continued on with strength and perseverance.

After being Honorably Discharged from the Air Force, my dad returned to Chicago, where he found comfort in the care of his parents. He remarried Gerri, and together they had two daughters, Lisa and Katharine. Gerri raised me as one of her own, and with her, my dad rebuilt his life.

Dad went on to work at an insurance company, quickly rising to Vice President, while attending night school at Northwestern University Law. In 1976, he earned his law degree and opened his own practice, Robert J. Adams & Associates, which focuses on helping those in financial distress through bankruptcy law. Today, that practice continues through me, one of his last words he said to me was "You are now the Bill Slayer".

Though his marriage to Gerri ended, and he faced more relationships, he never gave up on finding love. He married Marta, with whom he had two sons, Robert and Joseph. Marta and my dad remained close to the end. Later, he found lasting love with LiQun "Linda," who was with him to the end, offering unwavering support.

Dad loved his unconventional family deeply. He embraced us all, in our uniqueness and imperfections, with a heart full of acceptance and affection. He always wanted me to become an attorney and work alongside him. I began as a paralegal, then managing the team, and now I carry on his legacy as the attorney and owner of Robert J. Adams & Associates. Working with him was one of the greatest privileges of my life.

He was the first to see both of my sons when they were born and was a devoted grandfather until the very end. He was devastated when Robbie passed away in 2023, but remained a vibrant grandfather to Rickie and my nephew Joey, and my nieces Katharine and Isabelle He was a proud great-grandfather to Anthony, a joy that brightened his later years.

In March of this year, he met his cousin Louis Friend and his children for the first time, overjoyed to welcome them into the family—a moment that brought him immense happiness.

A lifelong proud liberal and Democrat, my dad stood firm in his beliefs and his commitment to justice and equality. He believed in standing up for the underdog and fighting for those without a voice. His values shaped both his personal and professional life, leaving a lasting imprint on everyone who knew him.

Dad was deeply grateful for the GI Bill, which provided him with access to education—a privilege he never took for granted. He often said he would not have become the educated man he was without it. His education opened doors for him and allowed him to help countless others.

My father's legacy is not just in his professional achievements, but in the way he lived his life—overcoming obstacles with determination, making lasting impacts on those around him, and being a loving father, husband, and friend. He was a dedicated mentor, an advocate for those in need, and an inspiration to all who had the privilege of knowing him. His vidoes can be seen on Tic-Tox, and they show how fun he was.
